# OUR MANUFACTURING



### **Meets International Standards**

Assessed against International Standards of ISO 14001 and ISO 9001, our manufacturing processes deliver quality, high-level service and products, while reducing our environmental burden.



### Solar Power

The use of solar panels attached to our key factory locations also means that your favourite acoustic products, including our FilaSorb™ felt and QuietBack™ carpet tiles, are generated using around 30-40% onsite renewables – powered by the sun.



# **End of Life Program**

Acoufelt have plans to partner with a local manufacturing plant and commence its own take-pack program, allowing consumers to return and recycle Acoufelt products at the end of their useful life.



# CONVERTING WASTE INTO INNOVATION.

A minimum of 60-80% recycled PET is used in our FilaSorb™ panels, and a minimum of 80% is used in the backing of our QuietBack™ carpet tiles.

The recycled PET is sourced from bottles that would normally go to landfill, closing the loop on a valuable resource.




Every square meter of FilaSorb™ diverts on average approximately 108 x 600ml PET drinking bottles from landfill.



Every square meter of QuietBack™ carpet tiles diverts on average approximately 34 x 600ml PET drinking bottles from landfill.



Acoufelt's QuietBack™ carpet tiles and FilaSorb™ collections are all made from post consumer recycled plastic drink bottles, diverted from landfill.




The regenerated fibers are clean and odorless like virgin fibers.



The discarded drink bottles are cleaned and cut into flakes before being melted and extruded into fibers of natural white color.



The regenerated fibers are then colored or printed and used to construct brand new products like carpet tiles, panels and baffles.



MATERIAL SAFETY AND ACCREDITATIONS.

At Acoufelt, we're transparent about the high-grade, safe and sustainable materials that go into our products.

We continue to use independent third-party organisations to list and assess the makeup of our products, and ensure all components are free from harmful chemicals, and adhere to international standards.

# What This Means



SCS is an international leader in third-party certification and standards development in environmental, sustainability and quality performance.

Acoufelt FilaSorb™ products receive SCS Indoor Advantage Gold certification for Indoor Air Quality, determined by comparing the calculated emission concentration or emission factor to the applicable Volatile Organic Compound (VOC) emission criteria under California Department of Public Health (CDPH) compliance.

Acoufelt FilaSorb™ products emit low concentrations of VOC's, making them safe for use, and qualifying them for building rating systems including LEED v4, BREEAM, and WELL.



CRI's Green Label program tests carpet, cushions and adhesives to help specifiers identify products with very low emissions of Volatile Organic Compounds (VOCs).

Acoufelt carpet tiles meets the requirements for Green Label Plus certification under Indoor Air Quality Testing, tested against the most stringent criteria for low chemical emissions

Acoufelt carpet tiles emit low concentrations of VOC's, making them safe for use.

# Declare.

Under the International Living Future Institute (ILFI), Declare transparency labels enable manufacturers to voluntarily disclose product information and ingredients, as assessed by the ILFI.

Acoufelt QuietBack™ carpet tiles, WoodBeQuiet™ planks and FilaSorb™ collections have received "LBC Red List Free" declaration status – having disclosed 100% of product ingredients at or above 100 ppm (0.01%) in the final product, and not containing any Red List chemicals.

Acoufelt QuietBack™ carpet tiles, WoodBeQuiet™ planks and FilaSorb™ collections don't contain materials, chemicals and elements known to pose serious risks to human health and the greater ecosystem.
