The below entails how Acoufelt products can contribute points toward WELL Certification in your building projects.

Criteria

Sound Reducing Surfaces. S05.1 Implement Sound Reducing Surfaces

Requirement and points awarded

Tier 1 = 1 point

Open workspaces – NRC 0.75 or 75% of available ceiling area

Furniture – N/A

Conference/Learning area – NRC 0.50 for 50% available ceiling area

Tier 2 = 2 points

Open workspaces – NRC 0.90 for all available ceiling area

Furniture – 4ft above floor level NRC 0.70 between workstations

Conference/Learning area – NRC 0.90 for all available ceiling area

Materials Transparency. X06.2 restrict VOC emissions from furniture, architectural and interior products

Requirement and points awarded

Points = 1 point for one product, 2 for two compliant products

Wall – at least 75% of cost by surface area

1 point: for at least 25 distinct permanently installed products (including flooring, insulation, wet-applied products, ceiling and wall assemblies and systems), furniture and task and floor lamps, ingredients are disclosed by the manufacturer, a disclosure organisation or a third party

Requirement and points awarded

- all ingredients are disclosed down to 100ppm
- all ingredients are publicly disclosed by the manufacturer, a disclosure organisation or a third party
